



He Oranga Poutama Funding Initiative Privacy Statement

Information We Collect:

Personal Information: We may collect personal information such as your name, contact details (including email address, phone number, and physical address), date of birth, gender, and other identifying information necessary for processing your funding application.

Financial Information: In some cases, we may require financial information, such as income details or financial statements, to assess your eligibility for funding.

How We Use Your Information:

Please note information on who we fund, the project and the outcomes including information provided for reporting may be shared between Te Pae Oranga, Sport Manawatū and Sport NZ – Ihi Aotearoa.

Processing Your Application: We use the information you provide to process your funding application, assess your eligibility, and make decisions regarding funding allocation.

Communications: We may use your contact information to communicate with you about your application status, request additional information if necessary, and provide updates regarding our programs and services.

Statistical Analysis: We may anonymise and aggregate the information collected to conduct statistical analysis, improve our programs, and better understand the needs of our Māori communities.

Reporting Information: Any information provided, including images, may be used for marketing, promotional or further reporting purposes in relation to the He Oranga Poutama fund.

Data Security:

We take the security of your personal information seriously and have implemented appropriate technical and organisational measures to safeguard your data against unauthorised access, alteration, disclosure, or destruction.

Disclosure of Information:

We do not disclose your personal information to third parties outside of the three partnership organisations unless required by law or with your explicit consent. Your information is only shared with authorized personnel involved in the processing of your funding application.

Retention of Information:

We retain your personal information only for a seven year period, as required by law. After the retention period, your information will be securely disposed of or anonymised.

Your Rights:

Access and Correction: You have the right to access and update the personal information we hold about you. If you believe that any information we have is inaccurate or incomplete, please contact us to make the necessary corrections.

Withdrawal of Consent: You have the right to withdraw your consent for the processing of your personal information at any time. However, please note that withdrawing consent may affect our ability to process your funding application.

Privacy Act 2020: The Privacy Act 2020 covers how we collect and store personal information, including personal information provided with applications for funding, and what procedures are required to protect the security of that information. It also covers how long we can keep personal information, what the personal information can be used for and when it can be disclosed. Official Information Act 1982: The Official Information Act 1982 (OIA) covers how Sport NZ must handle OIA requests received by members of the public. Applications for funding are among the documents that can be requested under the OIA. The general expectation, as expressed by the Chief Ombudsman, is for official information to be released (in response to a request), unless there are clear grounds to withhold it.

Personal information provided with your application will not be released.

If you consider that some of the information provided in your application is 'commercial in confidence' this information should be clearly marked in your application.

Please note: as a Crown Entity Sport NZ may release the name of your organisation and the funding you receive on its website as part of its commitment to Open Government.
